Jozi Cats Rugby Club Injury and Liability Waiver

I, the undersigned, hereby acknowledge that:

1. I am fully aware that rugby is an extreme sport and as such is a test of my physical and mental abilities and carries with it the potential for death, injury and property loss.
2. Without derogating from the generality of the aforesaid, these risks include, but are not limited to patrimonial loss, death, injury and property damage or loss caused directly or indirectly by the actions or omissions of other people including, but not limited to, the Jozi Cats Rugby Club NPO 169-144 (hereinafter referred to as “the Club”), its directors, members, management, sponsors, participants, volunteers, spectators, coaches, event officials, event monitors and/or producers of the event; lack of hydration, weather conditions, and/or other natural conditions.
3. I hereby voluntarily assume all of the risks of participating in (which includes actively participating in, attending or being present at) events.
4. I understand that these events include activities of any nature organised by or incidental to the Club including, but not limited to, formal events, informal events, social events, matches, training, contact rugby matches and training, touch rugby matches and training and coaching.
5. I certify that I am physically fit, have sufficiently prepared for participation in events and have not been advised otherwise by a qualified medical person. I agree to immediately inform the Club should I be so advised at any time or any future date and that such disclosure will be treated as in clause 6 below.
6. I acknowledge that any medical condition disclosed by me at any time to the Club is for information purposes only and I acknowledge that I take full responsibility for participating in events, continuing to participate in an event and for ceasing to participate in an event. I agree that such disclosures place no duty (legal or otherwise) on the Club to act or not to act in any way and as such I hereby now and forever discharge the Club from any such duty. It is furthermore in the discretion of the club to allow me to take part in any Club activities if in its opinion any medical condition I may suffer from may pose a risk to me or any other member associated with the club or any other person.

I acknowledge that this form will be used by the Club.

In consideration of my application and permitting me to participate in events, I myself and on behalf of my executors, administrators, heirs, next of kin, successors and assigns hereby waive, release, and discharge the Club, its directors, members, management, coaches, sponsors, agents, facility providers and volunteers from any and all liability whatsoever, howsoever arising, whether directly or indirectly, for patrimonial loss, my death, disability, personal injury, property damage or loss thereof or actions, of any kind, which may hereafter accrue to me. This clause is extended to include travelling to, from or during any event.

In respect of the clause above I understand that this means that should I die, be injured, be disabled or where my property is damaged or lost, neither I nor my executors, administrators, heirs, next of kin, successors and assigns can hold the Club, its directors, members, management, coaches, sponsors, agents, facility providers and volunteers legally liable for such death, disability, injury or property loss or damage.

Consent to medical treatment

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during events.

Consent to photographs, filming and recordings

1. I understand that during events or related activities I may be photographed, filmed and / or recorded (including voice) and that footage, photographs and such recordings may be utilised by the Club, persons appointed by them, event organisers, producers, sponsors and / or their assignees at their sole discretion, to promote the Club or for any legitimate purpose. I therefore agree to allow my photo, video, recording or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organisers, and/or assigns. I agree that having given my consent in terms hereof, such consent may not be withdrawn in future.
2. The provisions of this waiver apply equally (*mutatis mutandis*) to the use of such photo, video, recording or film.
